## April Tree Planting Project

### Volunteers needed !

The dates are set for the tree planting with some slight revisions to earlier plans. I have made arrangements with Reed School, Fleet Environmental and finalizing with the Lions Club, Town and Country garden club and Planter's Choice Nursery. I will order the caging material from Newtown Hardware next week.

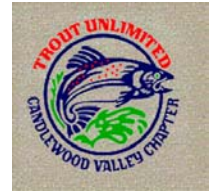
We will have about 40 large trees, 100-150 small white spruce, 200 small trees and shrubs (red twig, swamp oak, pin oak, spice bush, etc.). Schedule as follows.

April 24th Monday- Planter's Choice delivery of trees. At 2 or 3PM Fleet Environmental will bring machines and some laborers down to help plant large trees, about 40 trees.

April 25th (Rain date 27th) 9:30 first wave of Reed students come down until 11:00. A second wave will follow at 11:00 for 1 1/2 hours again. We will plant many of the small trees and shrubs. We will need adults to help dig the small holes ahead of them as much as possible. We can continue for a while afterwards doing caging, etc. The garden club will help and a few Lions members should as well.

Depending upon how much we get done we can follow up on next day(s) with Saturday April 29th as a day where we can get weekend-only folks to come out and finish any caging, planting, watering, etc. that's needed. The white spruce shouldn't need caging, but most of rest will. Meet at 9:00 AM.

The meeting place is at Deep Brook on Old Farm Rd. by the bridge, behind Reed School and Gov.'s Horse Guard off Wasserman Way.

## SPEAKER'S FORUM

April '06

Every year members of our T.U. Chapter head for exotic and remote places to pursue their love of fly fishing. At our April meeting Doug Peterson, with some help from his friends, will present one of these trips.

In April 2005 four of our members traveled to fish three of the most fabled trout streams in the American Southwest. They floated and waded the San Juan River in New Mexico, the Colorado River at Lees Ferry, Arizona and the Green River at Flaming Gorge, Utah.

At our April meeting you'll get to see the spectacular and different scenery each location offered. You'll see weather that ranged from hot to near blizzard and of course you will see Tony Ballato, Len Carrescia, Gene Rinaldi and Doug Peterson catching fish, holding fish, losing fish and talking about fish.

As a bonus, all of the information necessary for you to make a trip to these rivers will be part of the presentation. Transportation, both air and ground, lodging, guides, food, fly shops and even tips will be discussed. When you leave, we hope you have the basic knowledge to plan a similar trip, and feel comfortable with that information. So, if you want to "go west, young man, go west", bring your questions and get your answers at our April meeting.

## Try this fly

Tony Mortimer

I tied up some of these for the Banquet and will run this article once more because this fly is useful all year long. This is a great fly, I've had good success with it in Montana and in local rivers. I use it as the first nymph (it's heavy and sinks the rig faster) and a smaller dropper nymph tied on to a piece of tippet 12+ inches long (I tie it to the Copper John eye so the hook is better available to the fish). The fish hit the Copper John as often or more often than the dropper, but this offers the trout two sizes and patterns of flies. In Montana, I used it in a hopper/Copper/dropper three-way as recommended by its originator, John Barr.

I tie them in several colors of wire (green, Chartreuse, red, wine). If you don't have thinskin, use other dark nymph case material (or use cut strips of polyethylene baggie material coloring the underside black with a permanent marker – I've done this with clear thinskin which is flexible vinyl, I think). Go to the website below and see the details of each tying step. The method of applying the partridge legs is the easiest/best way I know to get the legs the right length and look on a nymph. This is a terrific site to see patterns and learn how to tie and use them (click on the "Tutorial" details)

### Copper John (John Barr)

Hook: TMC 5262 #12-18 (2XL, heavy hook)

Thread: Black 70 Denier,

Bead: Gold colored Brass or Tungsten, sized to hook. (and a few wraps of lead wire for additional weight up against bead if you really want to get it down in faster water—the web site shows this and I tie mine that way)

Tail: Dark Brown Goose Biot

Body: Wapsi UTC Wire, Color of Choice, sized to hook.

Flashback: Pearl Flashabou

Wingcase: Black Thinskin

Thorax: Peacock Herl

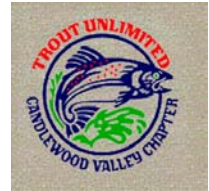
Legs: Hungarian Partridge

Wingcase Coating: 5 Minute Epoxy  
(or you could use clear nail polish)

## **Talk about fishing and share your pictures on CVTU's website**

We've recently added two new functions to our website -- a discussion forum and a photo gallery. These new tools provide an online meeting place for TU members and those interested in our chapter's activities. Web site is: [www.cvtu.org](http://www.cvtu.org)

### **A place to talk**

The discussion forum is a place where we can have discussions about fish, fishing, gear, conservation and practically any other topic (within reason) that our members find interesting. The great thing about a discussion forum is that many people can participate in the discussion without all having to be online at the same time. Each discussion thread is saved and visible to others. You can come and reply to a topic already posted or post your own topic to start a new thread.

Two helpful functions available on the forum is the "Watch this Forum" and the "Watch this Topic" functions. These functions send you emails when there is activity on the forum or topic that you're watching. Each Forum (e.g. Find a Fishing Partner, Fisher Reports, etc) can be watched for new topics. And each Topic can be watched for replies. There is a link below each forum and topic that allow you to toggle the "watch" function on and off. This is a very handy function if you aren't visiting the forums regularly.

### **A place to share photos**

The photo gallery is just that -- a place where members can share photos of their fishing activities. You can either post in the topic related galleries (e.g. Deep Brook & Pootatuck, Saltwater, etc) or you can post in your own photo album in the gallery. Photos are limited to 512KB in size so you'll have to resize any that are larger. You'll find a link in the FAQ to a free utility that resizes photos.

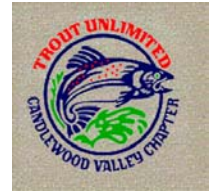
### **Registration Required -- it's fast and easy**

In order to post your comments and pictures both the forum and the gallery require registration. The process is fast and easy. On the Discussion Forum, select "Register" from the top menu bar and fill-out the form. On the Photo Gallery, select the "Register" link at the top of the page and fill out the form. The Photo Gallery requires one more step in order to register. You must click on the link in an email that the gallery will send to the email address you included in your registration. Once you click on that link your account will be active.

### **Privacy Assured**

While registration does require an email address, to ensure your privacy, the forums and gallery are set to hide your email address. The email address is only used by the system to either validate your registration or send you messages when you're watching a forum or topic. So, your personal information is not visible to users or spammers.

Congratulations to John Kumisky, as he has his fishing store back up and running at the same location. Stop in and see the progress and say hello to John.

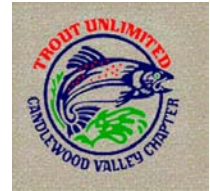
### **Compleat Angler Store has Moved**

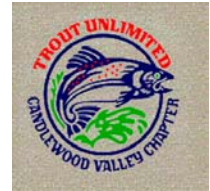

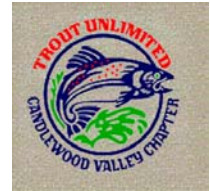

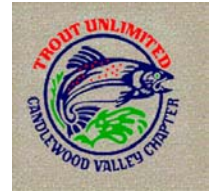

-New Fairfield HS Salmon egg incubator program with the Ct. River Salmon Federation.

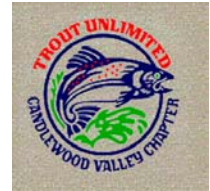

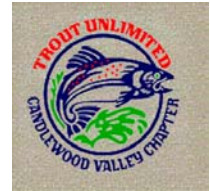

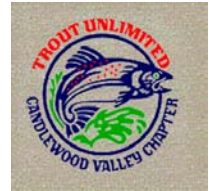
