### James Belden

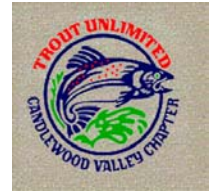
Amid a winter with spates of cold snowy days surrounded by spring-like days, we are lucky enough to occasionally hit the rivers and streams and find that yes, a few fish did survive this brutal summer. Of course, a better part of a year with low water followed by near record level rains did indeed turn our rivers and streams upside down. The good news is that with the continued efforts of TU and our partners we can see how the waters, and the aquatic life in them, are renewed each year as long as the natural systems they depend upon are intact.

Unfortunately much of our effort has to be in restoration of what should have always been protected, but as we do this we must be diligent in conserving and protecting what remains, especially the last surviving native brook trout and the habitat they depend upon. This is why TU focuses on so many aspects of water and fisheries management. Protecting the intricate web that allows for wild and native fish to populate our streams and rivers encompasses many issues including water withdrawals, the many affects of urban sprawl, fisheries regulations and contamination. Let's also not forget that our drinking water supplies and recreational resources are often closely related to these trout streams, and the as an indicator of overall water quality, the trout is the canary in the coal mine.

## SPEAKER'S FORUM

### Jerry Rekart

Our speaker for the February 14 meeting will be Tony Ballato giving a presentation of a trip to Diana Lake Lodge in extreme northern Quebec. In January of 2004, our guest speaker was Joe Stefanski, manager of High Arctic Adventures, owned by the Inuit Indians, and consisting of Diane Lake Lodge and Lake Tierney Lodge in extreme Northern Quebec.

In August of 2005, four of our chapter members, Tony Ballato, Len Carrescia, Steve Grover, and Gary Whipple, took advantage of this introduction to fulfill a long standing desire, traveling to Northern Quebec, Nunavik territory, to sample the incredible fishing at Diana Lake Lodge.

Diana Lake Lodge is located forty miles northwest of Kuujuaq, Quebec (formerly Fort Chimo, the Hudson Bay Company established its first trading post in North America here in 1830). The lodge is on a lake and river system sixty five miles long that makes its way to Ungava Bay where endless sea-run Arctic Char lay in icy, clear water. The water system is filled with rocky pockets and clear shorelines.

The week long stay involved various trips by boat to remote sites from the camp, during a very unusual warm period of their short summer, to angle for large Brook and Lake Trout, often using only dry flies! A number of rare Arctic Char were also caught.

Everything involved in planning the trip, from best times to go, expenses, how to get there and equipment needed, will be discussed. Come join us for a great presentation on a trip to exotic and unusual part of the world !!

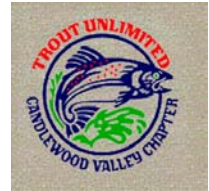

## **Talk about fishing and share your pictures on CVTU's website**

We've recently added two new functions to our website -- a discussion forum and a photo gallery. These new tools provide an online meeting place for TU members and those interested in our chapter's activities. Web site is: [www.cvtu.org](http://www.cvtu.org)

### **A place to talk**

The discussion forum is a place where we can have discussions about fish, fishing, gear, conservation and practically any other topic (within reason) that our members find interesting. The great thing about a discussion forum is that many people can participate in the discussion without all having to be online at the same time. Each discussion thread is saved and visible to others. You can come and reply to a topic already posted or post your own topic to start a new thread.

Two helpful functions available on the forum is the "Watch this Forum" and the "Watch this Topic" functions. These functions send you emails when there is activity on the forum or topic that you're watching. Each Forum (e.g. Find a Fishing Partner, Fisher Reports, etc) can be watched for new topics. And each Topic can be watched for replies. There is a link below each forum and topic that allow you to toggle the "watch" function on and off. This is a very handy function if you aren't visiting the forums regularly.

### **A place to share photos**

The photo gallery is just that -- a place where members can share photos of their fishing activities. You can either post in the topic related galleries (e.g. Deep Brook & Pootatuck, Saltwater, etc) or you can post in your own photo album in the gallery. Photos are limited to 512KB in size so you'll have to resize any that are larger. You'll find a link in the FAQ to a free utility that resizes photos.

### **Registration Required -- it's fast and easy**

In order to post your comments and pictures both the forum and the gallery require registration. The process is fast and easy. On the Discussion Forum, select "Register" from the top menu bar and fill-out the form. On the Photo Gallery, select the "Register" link at the top of the page and fill out the form. The Photo Gallery requires one more step in order to register. You must click on the link in an email that the gallery will send to the email address you included in your registration. Once you click on that link your account will be active.

### **Privacy Assured**

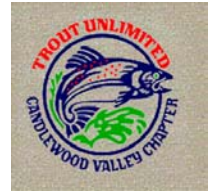
While registration does require an email address, to ensure your privacy, the forums and gallery are set to hide your email address. The email address is only used by the system to either validate your registration or send you messages when you're watching a forum or topic. So, your personal information is not visible to users or spammers.

As of the end of January, we have scheduled our CVTU fishing trips for the year. While some of the trips are still in their early stages of planning, at least two of them are set and ready for member commitments, and a third, the trip to Long Island in November, is also now firm for November 2. Please mark your calendars for it.

By the end of February, we are looking for members to commit to the Central Pennsylvania and to Cape Cod trips. We are going to take these commitments in two steps; an emailed "early commitment" (to [gary.whipple@cvtu.org](mailto:gary.whipple@cvtu.org)), or a signup at the February Meeting, or a signup under the forums ([www.cvtu.org/forums/trips](http://www.cvtu.org/forums/trips)) will hold your place on these two trips. A non refundable, money deposit is also due by the end of February to continue your participation. If at the end of February, we have inadequate sign-ups, we will cancel the trips and refund your deposits.

Additional details about the trip to Pennsylvania to fish from Rocco Rosamilia's fish camp (we are staying there the nights of May 18, 19 and 20; those of you who are still working may choose to come for the nights of May 19 and 20 only) will be covered at the February Meeting. Room charges are in the low \$40's per night, and guides are available. A deposit of \$25.00 by the end of February will hold your place on this trip.
