Deep Brook/Pootatuck Project Updates James Belden

We have had a busy Summer which will continue with a busy Fall. It is good to get back to meetings and the opportunity to inform everyone of the efforts. Water has been extremely low this year and our water resources under a great amount of stress, but hopefully with our continued work the trout and other species will have a greater chance to survive these tough times. Let's hope for a wet Fall.

In June we completed two stream bank restoration projects. The first, on Deep Brook, was part of our TU Embrace-a-Stream grant where we performed log jam construction and bank bio-engineering along 120 feet of bank. This project will reduce erosion, create habitat for fish and other aquatic life while improving the buffer to the stream.

The second project was on the Pootatuck as part of our agreement with the Town of Newtown to perform Supplementary Environmental Program (SEP) work in lieu of a fine to the EPA for last year's oil spill. This project, similar to the Deep Brook project repaired over 80 feet of bank in the WTMA. We will wrap up work on these projects with a **tree planting project on September 30th and October 1st, when we will need volunteers.** Additionally we may be receiving more SEP money to perform additional work on Deep Brook next year. Plans include the purchase and maintenance of several thermographs at strategic locations to identify thermal contamination threats in the WTMA.

Also as part of the Town's SEP program we will be conducting a macroinvertebrate study on Deep Brook and the Pootatuck in the WTMA. We will be conducting sampling in the Fall and Spring over the next two years in conjunction with the DEP. Anyone interested in taking part should plan on attending the **training class on October 22nd** at the Newtown Water Treatment Facility after which we will conduct the first sampling. Not only does this provide an opportunity to help with our scientific analysis of water quality but an excellent opportunity for trout fishermen to learn more about aquatic insects and what the trout feed on.

Thanks to TU's involvement at several public hearings held by the Newtown Conservation Commission many changes were made to a Toll Bros. plan for an age restricted condo complex on the banks of the Pootatuck. Notable changes are the inclusion of dedicated open space and conservation easement buffers, a reduction in units increasing the distance from the stream and eliminating disturbance on a very steep slope in addition to better storm water management. Town staff and Commission members were very appreciative of our involvement. TU has also been working with other groups on creating a watershed protection association for the Pootatuck watershed. This group will be a great asset for helping leverage TU's conservation efforts with other organizations in the Town.



Macroinvertebrate Study Joe Hovious

Background – The Town of Newtown has entered into a Compliance Order on Consent with the US Environmental Protection Agency as the result of an oil spill at the Reed Intermediate School. As a part of this Order, the Candlewood Valley Chapter of Trout Unlimited (CVTU) agreed to conduct a Supplemental Environmental Project (SEP) to study macroinvertebrate life in the area of the spill. Macroinvertebrate populations are continually exposed to stream conditions and are important indicators of ongoing stream health and water quality. The Town will give CVTU \$4300 to conduct the studies.

Study Objectives: Collect macroinvertebrate population data and use this data to assess existing stream health, water quality, water quality changes, and identify potential threats in the Deep Brook/ Pootatuck Wild Trout Management area (WTMA). As necessary, use the data to aid in the development of remediation strategies and goals. Provide educational opportunities on water quality through involvement of citizens and students in these studies.

Sampling Technique: Based on the discussion of study goals/objectives and the anticipated available resources, Connecticut Department of Environmental Protection (CT DEP) personnel recommend that the Rapid Bioassessment in Wadeable Streams & Rivers by Volunteer Monitors Protocol (RBV) be used for macroinvertebrate sampling. There are several advantages to the RBV program, it is currently used statewide, it is managed by the CT DEP, it is relatively simple, quick, does not require extensive resources, and works very well to screen for very high or very low water quality. Samples can be collected by Candlewood Valley Trout Unlimited members or others who are trained in the protocol. CT DEP (Mike Beauchene) will verify identification of samples.

Sample Locations: After an onsite review with CT DEP personnel, six sampling locations are suggested. Each of the proposed sample sites has some historical data collected by CT DEP between 1980 and 1997. Sites 1-3 on Deep Brook are most critical to the SEP. Sites on the Pootatuck provide additional data on the WTMA and additional background on a high quality stream in the immediate area. The number of sites sampled will be dependent of the number of people available to collect samples. 1 1/2 to 2 hours per sample locations for 3 people are required to collect a set of samples. Each of these sample locations is in a shallow riffle with a cobble/gravel/boulder bottom.

Sample Timing: An advantage to using the macroinvertebrate community to assess water quality is that the resident organisms reflect water quality conditions for the recent past. The community structure (abundance and types of species present) varies with the time of year. In general the low-flow summer months are the most stressful time for many aquatic organisms due to reduced flows, higher temperatures, increased in-stream concentration of stressors (if present). Therefore the CT DEP samples the macroinvertebrate community during a fall index period (October and November). Macroinvertebrate community samples collected in this window tend to reflect the "worst case" condition.

Other Data:

Photographic Records – A digital photo of each sample site at the time of each sampling event will be collected.

Water temperature data – Summer temperatures are critical to a cold water fishery. Some historical data have been collected. An ongoing sampling program is recommended. CT DEP currently uses the HOBO WATER TEMP PRO model for data collection. CVTU will determine if resources are avail

able to purchase monitors for use in this study. Water Chemistry – stream chemistry data can be of limited value in that they indicate the conditions only at the time of the sample. In addition, high quality chemistry data are relative expensive. However, there are some specific data related to stream threats that could be useful such as hydrocarbons (oil spills) and salinity (salt shed discharge). Some additional data may be available on pesticides originating from “Oil Creek”. CVTU recently purchased a hydrocarbon monitoring system for Newtown High School and will work with the Science department to obtain data on hydrocarbons and salinity as well as other important chemistry information.

Fish sampling data – CT DEP Department of Fisheries periodically collect electro shocking data on Deep Brook and the Pootatuck

Consultants/Additional Resources: CVTU plans to hire a Coordinator for each sampling event to organize and help in sample collection and delivery to DEP. The Coordinator would be paid on a task dependent basis. Some additional tasks for the Coordinator could be to assist in baseline and ongoing data analysis and presentation to interested parties. Tentative plans are to hire a student from the University of Connecticut Fisheries program to act as the sampling Coordinator.

CT DEP personnel will assist in training and data analysis and consult for 2-3 years.

Training: - A training date of October 22 has been set at the Aquarion offices on Commerce Road in

Newtown. **We need 15 volunteers from TU to take the training and help collect the samples.** Time commitment is the one day of training followed by one day of sampling once/year. Your involvement will help you make the Pootatuck a better fishery. **It will also help you better understand insect life and make you a better fisher-person.** Please call James Belden 426-6039 or Joe Hovious 270-1960 to volunteer. Thanks!

Our projects have been and are being publicized by TU national in their publications. The most recent Annual Report had a picture and note about the tree planting project last Fall and it looks like in the next edition of Trout Andy Belden will be running a short piece about the SEP project work and EAS which I recently worked on with him. There have also been several Bee articles and News-Times articles on the projects.

We really need broader chapter participation for the projects. Your money and support are greatly appreciated, but a very small number of folks are doing the actual work and would enjoy seeing more of us out there helping out. There is always a variety of light and heavier work, so don't be intimidated !




